Speakers will share perspectives from national patient safety leadership and research.	What value does credentialing create for pharmacists, employers and the profession? Through a facilitated discussion with credentialed pharmacists and pharmacy employers, this session will explore the motivations for pursuing credentialing, the impact it can have on professional development and career progression, and the benefits it can bring to organisations, services and patient care. Delegates will be invited to contribute their own perspectives.	How can pharmacists and pharmaceutical scientists translate scientific innovation into better patient care? 	Medicines safety: Emerging priorities, system learning and improving patient outcomes	Prescribing excellence in a changing landscape: empowering leadership and workforce advancement	Pharmacy preparedness for emerging health threats	Session delivered by UKCPA Ready for genomics? 	Medicines safety is a critical and evolving area of healthcare practice, requiring pharmacists to stay informed of emerging risks, national priorities and strategies for reducing patient harm. This session will explore key medicines safety challenges across healthcare settings, with expert speakers sharing insights from national patient safety programmes, medication-related incidents and system-wide improvement initiatives. We will also examine the role of human factors in medicines safety, highlighting how organisational culture, communication, processes and system design can influence medication use and patient outcomes.	Pharmacist prescribing is evolving at pace across GB, reshaping clinical pathways, professional identity and the way patients experience care. This session brings together leaders from across pharmacy to explore how prescribing roles are expanding, what excellence looks like in different settings, and how pharmacists can adapt, influence and thrive in a rapidly changing landscape. It will highlight the innovations driving progress, the challenges we must collectively overcome, and the opportunities emerging for pharmacists to take on expanded roles, lead service redesign, and improve patient outcomes.	This session will focus on the evolving role of pharmaceutical scientists and pharmacists in safeguarding patients. We'll start with future-focused patient or practice scenarios (e.g. changing patterns of medicine use, emerging pathogens, or supply challenges) and work backward to explore the science, evidence, and leadership required to ensure safe, effective care. The session will connect scientific research and emerging trends directly to real-world patient outcomes, highlighting the profession's role in shaping the future of medicines safety.	As genomic medicine becomes increasingly embedded in healthcare, pharmacy professionals have a key role in leading its safe and effective use. This interactive session will explore how pharmacogenomics is being translated into everyday practice, highlighting key evidence, resources and the new UKCPA Handbook of Pharmacogenomics. Through case-based discussions and expert insights, delegates will consider how genomic technologies can support personalised prescribing, optimise treatment outcomes and reduce adverse drug reactions, while exploring future opportunities for pharmacy leadership and innovation across healthcare settings.
